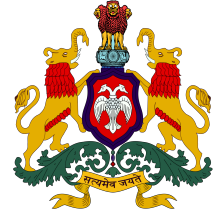

3. Any food business activity carried out during such suspension period shall be deemed non-compliant of the provision of the FSS Act, 2006 and the regulations shall attract subsequent action including penalty under the FSS Act, 2006
4. In the event of closure of business, the food business operator shall, within thirty days from the date of such closure, surrender the registration certificate by login into FSSAI's Food Safet Compliance System(<https://foscoc.fssai.gov.in>) with your user id and password.
